SBA will only accept registration for Singapore Youth International Series base on the following criteria for U15 and U17.

- a) Players must attain a TOP 4 position (Singles/Doubles accordingly) in SBA sanctioned Tier-2 and above competitions or
- b) Players must attain a TOP 2 position (Singles/Doubles accordingly) in SBA sanctioned Tier-3 and 4 competitions

\*The above criteria are not applicable for players within SBA national setup and all U13 players.

\*The SBA Development and Selection Committee reserve the right to make the final decision over the registration of players.

\*For BWF and BA competition that are stated above (other than Badminton Asia Junior Championship, World Junior Championship and Badminton Asia U15 U17), SBA will submit and rank the entries base on SBA local ranking system.
