

SBA NATIONAL INTERMEDIATE SQUAD TRAINING BURSARY

OBJECTIVE

1. To provide financial assistance to talented young athletes from needy families so as to help defray the cost of training in the SBA National Intermediate Squad.

QUANTUM

2. Up to 10 bursaries shall be awarded annually.
3. Each bursary recipient will receive a full subsidy each month based on the SBA monthly training fees up to one calendar year.

ELIGIBILITY

Bursary recipient must qualify for all the conditions listed below from point 4 to point 8:

4. Singapore Citizen,
5. A player from SBA National Intermediate Squad,
6. Household per capita income less than \$800 per month,
7. Not receiving any other financial assistance related to badminton, and
8. Not receiving private training sessions in badminton sports for which fees are payable.

APPLICATION FOR BURSARY

9. Parent or legal guardian of applicant can apply for the subsidy by submitting the duly completed hardcopy application form to SBA.
10. Successful recipients will be informed via email.

SELECTION CRITERIA

11. All applicants will be assessed holistically.
12. This includes the applicant's:
 - a. Result in local and/or international tournaments.
 - b. Conduct and/or attitude in school.
 - c. Conduct during training and competitions.
13. SBA reserves the right to award the bursaries in its absolute discretion, and the decision on the selection outcome is final.

Household per capita income is calculated by taking the total gross household monthly income divided by the total number of family members living together under the same address.

OTHER CONDITIONS

14. The bursary will be withdrawn immediately, if the recipient, at any time,
 - fails to satisfy the eligibility conditions stated in point 4 to 8,
 - fails to adhere to SBA rules, regulations or instructions,
 - fails to maintain proper discipline,
 - engages in any misconduct, or
 - brings disrepute to SBA or Badminton sport.

15. If any information provided during the application is false or inaccurate, the parent or legal guardian of the subsidy beneficiary is also liable to repay in full the bursary amount received and any administrative expenses incurred by SBA.

16. SBA has the right to make any amendments to the terms and conditions of this Bursary without prior notice.
